### MARKET LIVESTOCK EXHIBITOR AGREEMENT FORM

***Exhibitors must complete the following 3 forms:***

- 1) **NAJLA EXHIBITOR AGREEMENT FORM** due May 9.
- 2) **NAJLA MARKET REGISTRATION FORM** for each market animal you are entering in the Fair.
- 3) **COCONINO COUNTY FAIR 4-H LIVESTOCK REGISTRATION FORM** for each market animal you will be entering into the Fair. This form is available in the Coconino County Fairbook.

***By signing this form;***

- ***I understand*** it is my responsibility to complete and mail the required three forms listed above.
- ***I understand*** the ownership and postmark deadlines for entry in the Coconino County Junior Livestock Auction for all market animals I will be entering.
- ***I understand*** that all required information; pictures, ear tags, ear notches, and signatures must be **completed according to instructions, and sent to NAJLA by the stated postmark date in order to be eligible** for the Coconino County Fair Junior Livestock Auction.
- ***I understand the Late Registration Policy.***
- ***I understand*** if my Market Registration form is missing any of the required items, my registration will be incomplete and not accepted, making me ineligible for the Coconino County Jr. Livestock Auction.
- ***I understand that it is my responsibility*** to read the current NAJLA Auction Rules.

#### **MARKET LIVESTOCK EAR TAGS**

- Your project leader will give you an official NAJLA ear tag for each steer/pig/lamb/goat that you enter.
- If an ear tag comes out of your registered animal's ear after the ownership deadline date, contact the NAJLA Registration Committee Chair **immediately** by email [wje47@msn.com](mailto:wje47@msn.com) or phone (928)380-8143.
- A member of the Registration Committee will come to you and give you a replacement tag in exchange for your original tag.

#### **EXHIBITOR FEE AND SALE PERCENTAGES**

- NAJLA Livestock Rule Sec.II C5: There will be an Administrative Fee not to exceed 4% on Beef and 6% on Swine, Sheep, Meat Goats and Small Stock that sell through the Auction.
- An Exhibitor Fee of \$20.00 for Beef, Swine, Sheep & Goats, and \$10.00 for Small Stock will be deducted from each exhibitors check.

#### **DRUG TESTING**

- I understand that all market livestock is subject to drug testing.

#### **PHOTOGRAPHS**

- I give permission for NAJLA to use my photograph for advertising in print or in electronic and social media platforms.

**LATE REGISTRATION NOTICE**

Market Registrations received after the Postmark deadline, but no later than one week, will be charged a late fee of \$100.00 PER EXHIBIT. Late Registrations will not be accepted after 7 days past deadline.
